## PEAKS ISLAND FUND ENCOURAGES DONOR ADVISED FUNDS

There are two primary ways the Peaks Island Fund (PIF) will grow to have a significant effect on our community. The most common is for individuals to create estate gifts or bequests in their wills, whereby they transfer portions of their net worth to serve their community after they die. Most recently, Debbie Chase and John Funk joined a growing number of islanders who created legacy gifts to Peaks Island by naming the Peaks Island Fund as a beneficiary of their estate plans. As a

fective tool for meeting these needs, the Donor Advised Fund. Created by gifts of cash, stocks, real estate or other assets. this type of fund allows the donor to oversee the use of the charitable gifts during his or her lifetime, often directing income earned by the fund to charities and causes chosen by the donor. This provides the donor with a wonderful means of educating children or grandchildren about the importance of ef-

means of building greater autonomy for the island in financial matters, they encourage all island residents, year round and seasonal, to do the same. The PIF is most grateful to Deb and John for their commitment to the island endowment and has established a goal of adding 20 new legacy members in 2010.

The second way the Peaks Island Fund will grow is people will seize the opportunity to influence this community during their lifetimes and create "donor advised funds" while they are still alive to direct them. This is perhaps the most interesting and gratifying type of work accomplished by an organization like the Peaks Island Fund. It requires a unique partnership to work, and we are fortunate to have forged that partnership with the Maine Community Foundation (MaineCF). The MaineCF is the parent organization for PIF, offering administration, grant-making advice, and fund development services to PIF. The MaineCF is a statewide organization that helps communities all across Maine grow endowments for future funding of the existing and emerging needs of Maine's residents. The Maine Community Foundation has developed a most effective philanthropy to the long-term health of a community. Establishing a "donor advised fund" is not complicated and is within the financial means of many. Check it out at the PIF website.

Thanks to island residents and friends, the Peaks Island Fund experienced another year of growth. The PIF is grateful for the generosity of people, who make annual grants possible, and for those willing to contribute to the permanent endowment. During these difficult economic times, the PIF seems to have taken on greater significance in helping island charities sustain their missions. Financial challenges faced by island non-profits are reflected in the grant awards for 2009. We anticipate that 2010 will continue to be difficult and urge everyone to give as much as possible of time and money to keep vital services available on Peaks. Financial autonomy is a reasonable goal for a small community like Peaks. It is conceivable that we can take care of ourselves if we recognize the role each of us can play now and into the future. # 2009 GRANT AWARDS

**Brackett Memorial Church** has been awarded \$1,000 for roof repairs over the community hall.

**Fifth Maine Regiment Museum** will receive \$1,500 to develop curricula and hands on activities related to the Civil War period for elementary and middle school students. They will also use the funds to provide training for teachers.

The Peaks Island Music Association has been awarded \$550 for equipment to maintain and move the new community piano.

Home Start, the Peaks Island affordable housing program, has been awarded \$2,000 for costs associated with rezoning for the construction of two new homes on Luther Street.

## The Peaks Island

**Children's Workshop** has been granted \$2,000 for staff training related to developmental challenges, health and wellness, emotional and behavior management and multi-age programming. It has also received support of \$1,500 for board development through guidance offered by the Institute for Civic Leadership.

## The Peaks Island Elementary School

has been awarded \$2,300 for furniture to support touch-typing programs in the elementary school. It has also received an additional \$4,000 to support field trips and upgrade the collection of leveled books that are needed across all grades.

**Peaks Island Tax Assistance** will receive \$700 to purchase a digital projector that will be available for use by all island nonprofits. The projector will be stored at the Children's Workshop. The Peaks Environmental Action Team (PEAT) has been awarded \$4,150 for the purchase of a solar powered compacting container to be located at the Peaks Island Ferry terminal area. This completes a two-year project to reduce trash down front and to increase the number of recycling bins in use on the island.

> The PEAT Wind Group has received \$2,000 to support its application process and engineering studies related to a meteorological tower designed to determine whether Peaks Island can take advantage of wind power.

The PEAT Community Garden has been awarded \$1000 for construction costs incurred in building the garden's infrastructure.

## The Friends of TEIA

have received \$1,000 for 4 additional scholarships to the summer sailing camp. This grant assures that all island children interested in sailing are afforded the opportunity to attend the program.

The Casco Bay Health Center will receive up to \$3,000 for wiring installation throughout the center that will facilitate the use of laptops and electronic patient health records.

## The Wednesday Afternoon

**Enrichment Program**, a Peaks community effort to provide educational activities for elementary students, has been granted \$5,000 to support its schedule of activities.
